

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approving Construction for the Rainbow Treatment Center Projects in Cibecue and McNary)

- WHEREAS, the Rainbow Treatment Center is a Tribal program which offers substance abuse treatment and other programs to enhance the well-being of individuals and families; and
- WHEREAS, the Rainbow Treatment Center has earned funds through its Third-Party Billing Activities (Arizona State Medicaid Program/AHCCCS) which it has saved and budgeted for the construction of new facilities in the communities of Cibecue and McNary; and
- WHEREAS, the Tribal Council finds that Rainbow Treatment Center's plans to expand outpatient treatment services in the communities of Cibecue and McNary are in the Tribe's best interests; and
- WHEREAS, the Tribal Council finds that these projects should be implemented as well to further address the range of substance abuse treatment needs and options for families, couples, and individuals of all ages.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the leadership at Rainbow Treatment Center/The Division of Health Programs to seek out and retain architects, contractors, and other professionals to design and build two new outpatient buildings for the communities of Cibecue and McNary, subject to approval from the White Mountain Apache Tribe Legal Department.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that Rainbow Treatment Center is directed to provide therapeutic substance abuse treatment services to its clients at the new facilities to include substance abuse prevention services and outpatient individual, couples, family and group counseling for adults, adolescents and children.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it authorizes and directs the Tribal Chairman to execute and deliver the agreements on behalf of the Tribe related to future construction contract agreements.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

> The foregoing resolution was on JULY 29, 2014 duly adopted by a vote of TEN for, **ZERO** against, and **ZERO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
