

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Sunrise Park Resort Board of Directors)

WHEREAS, the Tribal Council is aware that Sunrise is vital to the winter economy and it affects the entire White Mountains area, and if managed effectively, has the potential to continue to strengthen the local economy as well as Tribal finances; and

WHEREAS, by authority of Resolution 10-2012-159, the Tribal Council appointed five (5) members to the Sunrise Park Resort Board of Directors; and thereafter, by authority of Resolutions 12-2012-181 and 12-2013-235, two of the original Board members were removed and Bill Greenwood and Chuck Teetsel were appointed to serve the remainder of their terms; and

WHEREAS, Jonathan Brooks, a tribal member and original board member appointment, is up for reinstatement following an initial 2-year term that expired October 2014; and

WHEREAS, Bill Greenwood's 2-year term expired October 2014; and

WHEREAS, Chuck Teetsel's term does not expire until October 2015, it is in the best interest of the enterprise that new and fresh perspectives are introduced; and

WHEREAS, an interim candidate has been identified to represent the Springerville-Eager area: Chris Chisel, Springerville Economic Development Director, is a suitable and willing candidate; and

WHEREAS, given the urgency of appointments, the Tribal Council further finds that the renewal of appointment needs to be considered and made outside of its regularly scheduled meeting; and

WHEREAS, the Tribal Council further finds that: (1) this Resolution may be voted upon by signature of a member of the Tribal Council where a signature indicates a vote for this Resolution, (2) the Tribal Council Secretary should attempt to obtain signatures for members of the Tribal Council personally, (3) no signature would mean that the respective Tribal Council member is against this Resolution, (4) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby reinstates Jonathan Brooks to a 3-year term and removes Bill Greenwood and Chuck Teetsel from the Board of Directors of Sunrise Park Resort and declares the seat represented by the Pinetop-Lakeside and Show Low area vacant and the identification of a suitable candidate forthcoming.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Chris Chisel as an interim board member to temporarily fill the 3-year Sunrise Park Resort board seat representing the Springerville and Eager area, until a suitable replacement is identified.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that given the urgency of the request described herein, this Resolution may be voted upon as follows: (a) by signature of a member of the Tribal Council, including the Chairman of the Tribal Council and the Vice-Chairman of the Tribal Council, where a signature indicates a vote for this Resolution, (b) the Tribal Council Secretary shall attempt to obtain signatures for members of the Tribal Council personally, (c) no signature shall mean that the respective Tribal Council member is against this Resolution, (d) the Tribal Council Secretary should wait no longer than a

reasonable period of time to obtain a vote by signature or by no signature, and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

> The foregoing resolution was on **DECEMBER** duly adopted by a vote of 7 for, against, and A abstention by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48) Stat. 984).
