

## WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approval for Peralta Kasey to Receive a HIP Home from the Fiscal Year 2013 Tribal Work Plan)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

WHEREAS, the White Mountain Apache Housing Authority ("WMAHA") administers the Housing Improvement Program ("HIP"); and

WHEREAS, by Tribal Council Resolution No. 10-2014-174, the Tribal Council previously approved and authorized the WMAHA to carry over Elizabeth Cody's eligibility for a HIP home from the Fiscal Year 2013 Tribal Work Plan to the top of the Fiscal Year 2015 Tribal Work Plan; and

WHEREAS, the Tribal Council must now select a Tribal member to receive this unit; and

**WHEREAS,** the Tribal Council selects Peralta Kasey as the Tribal member to receive a HIP home from the Fiscal Year 2013 Tribal Work Plan.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves and authorizes Peralta Kasey as the Tribal member to receive a HIP home from the Fiscal Year 2013 Tribal Work Plan.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
