



# WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

## (Approval to Grant Tribal Relinquishment Request of DILPER BUSH JR.)

**WHEREAS,** Tribal Member, Dilper Bush Jr., has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with San Carlos Apache Tribe; and

**WHEREAS,** the Tribal Enrollment Committee reviewed and approved the relinquishment requests at a duly called meeting; and

**WHEREAS,** the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee that the relinquishment from tribal membership be approved for Dilper Bush Jr..

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Dilper Bush Jr., along with any and all privileges accorded to members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove Dilper Bush Jr. from the membership rolls of the White Mountain Apache Tribe.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on March 04, 2015 duly adopted by a vote of NINE for, ONE against, with ONE abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
