(Approval to Sell Tribal Farm Equipment)

WHEREAS, the Tribal Farm has been presented with a proposed agreement of purchase whereby the equipment listed is to be sold to Integrated Machinery Incorporated, 25550 West Highway 85, Buckeye, Arizona 85326; and

WHEREAS, in exchange, the Tribal Farm would like a store credit of \$28,000.00 to purchase equipment and supplies needed at the farm; and

WHEREAS, the program has contacted the Property Management Office concerning the property list for their review and approval.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the sale of the equipment from the Tribal Farm, as set forth in the attached document, in exchange for store credit of \$28,000.00 to purchase equipment and supplies for the farm.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


