



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Reinstating Certain Police Department Personnel to 80 Hour Work Schedule Rotation and Amending the General Account Budget)

WHEREAS, the White Mountain Apache Tribe implemented budget reductions which decreased police recruits and other line items in the White Mountain Apache Police Department's ("WMAPD") general account funding; and

WHEREAS, the WMAPD requests the approval of the Tribal Council to return an administrative staff and records clerks to an eighty (80) hour work schedule rotation and to add three police recruit positions to the general account budget to address the shortage of law enforcement officers; and

WHEREAS, the administrative staff consists of one employee that conducts payment, timekeeping and other related duties and the three records clerks which are a vital part of the criminal justice system when reports are submitted for prosecution, statistical information for 638 contracts and for Uniform Crime Reports; and

WHEREAS, it is further requested that each clerk be rotated to an 80 hour work schedule to satisfy reporting requirements under 638 contract; and

WHEREAS, The Tribal Council finds it in the best interest of the Tribe authorize one administrative employee be restored to an eighty hour work schedule, allow three records clerk to rotate an eighty hour work schedule and to add three police recruit positions.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the amendments under the current Tribal general account funding for three additional police recruit officers to be added under the department's general account.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves Patricia Stover to an eighty hour work schedule to fulfill all administrative duties to the 638 contract for Law Enforcement Services.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the rotation of an eighty hour work schedule for three records clerks to satisfy the requirements for reporting for prosecution and 638 contractual agreements.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


