



# **WHITE MOUNTAIN APACHE TRIBE**

**A Sovereign Tribal Nation**

## **( Approving Gas and Credit Cards for Police Department )**

---

**WHEREAS,** the White Mountain Apache Police Department ("WMA PD") request the approval of the White Mountain Apache Tribal Council ("Tribal Council") for two gas credit cards and one pre-paid credit card; and

**WHEREAS,** the use of the two gas cards will be used by the Chief of Police and the Police Captain for the purpose of travels for meetings in Phoenix or other cities and emergencies (i.e. juvenile transportation etc.); and

**WHEREAS,** the gas cards will be paid using the Police Department funding sources for related travel; and

**WHEREAS,** the request for the pre-paid credit card will be used to pay for travel, training and emergency purchases for the WMA PD to be set at \$5,000.00; and

**WHEREAS,** the gas card and pre-paid credit card will be monitored by the Chief of Police and the Police Captain to effectuate the proper use of the gas cards according to the policies set forth; and

**WHEREAS,** misuse of these cards will be paid back by the personnel who uses such credit cards and will result in disciplinary action; and

**WHEREAS,** the Tribal Council finds it in the best interest of the Tribe and Public Safety to authorize and approve such movement to fulfill such request as indicated and considered hereto.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes and approves the request for the Police Department to be issued two (2) gas cards for the use of travel pertaining to law enforcement business.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes and approves a pre-paid credit card with a limit of \$5,000.00 for the use of travel, training and emergency purchases for police officers and the White Mountain Apache Police Department.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.






**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **APRIL 12, 2016** duly adopted by a vote of **EIGHT** for, **ZERO** against, and **TWO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
