



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Authorizing 80 Hours and Overtime for the Professional Standards Unit Officer)

- WHEREAS,** the White Mountain Apache Police Department ("WMAPD") has a low roster of certified police officers to service the amount of calls throughout the reservation; and
- WHEREAS,** the WMAPD currently has an employee in the Professional Standards Unit who is a certified police officer and is qualified to patrol the reservation as needed; and
- WHEREAS,** the WMAPD requests approval from the Tribal Council to reinstate the Professional Standards Unit Officer from 64 hours to 80 hours and overtime with the understanding that overtime will be used when patrol duties are assigned to the officer; and
- WHEREAS,** the Tribal Council finds it in the best interest of the Tribe to authorize the reinstatement of 80 hours and overtime for the Professional Standards Officer for public safety as indicated, effective immediately.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the reinstatement of 80 hours and overtime for the Professional Standards Officer for public safety as indicated, effective immediately.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby notifies the Tribal Business Office (i.e. Treasurer, Payroll and Comptroller) of such approved request.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **APRIL 12, 2016** duly adopted by a vote of **NINE** for, **ZERO** against, and **ONE** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
