WHEREAS, Cairo Clay, Renell Williams, Rose M. Kasey, Rhoda Ashley, Shyanne E. Dewaune, Merial Goklish, Marcia Altaha, Shannon James and Dewey Lupe have been nominated to serve as Fair and Rodeo Commissioners; and

WHEREAS, the Tribal Council believes that the appointment of the above individuals, on a voluntary basis, is in the best interest of the Tribe and the annual White Mountain Apache Tribal Fair & Rodeo festivities.

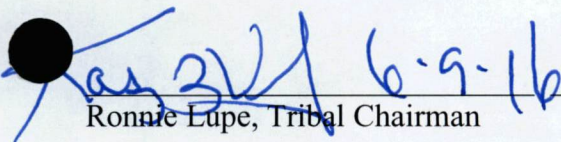
BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Cairo Clay, Renell Williams, Rose M. Kasey, Rhoda Ashley, Shyanne E. Dewaune, Merial Goklish, Marcia Altaha, Shannon James and Dewey Lupe to serve as Fair & Rodeo Commissioners on a voluntary basis.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

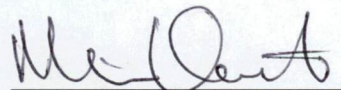
BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on MAY 16, 2016 duly adopted by a vote of TEN for and ZERO against with ONE abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).

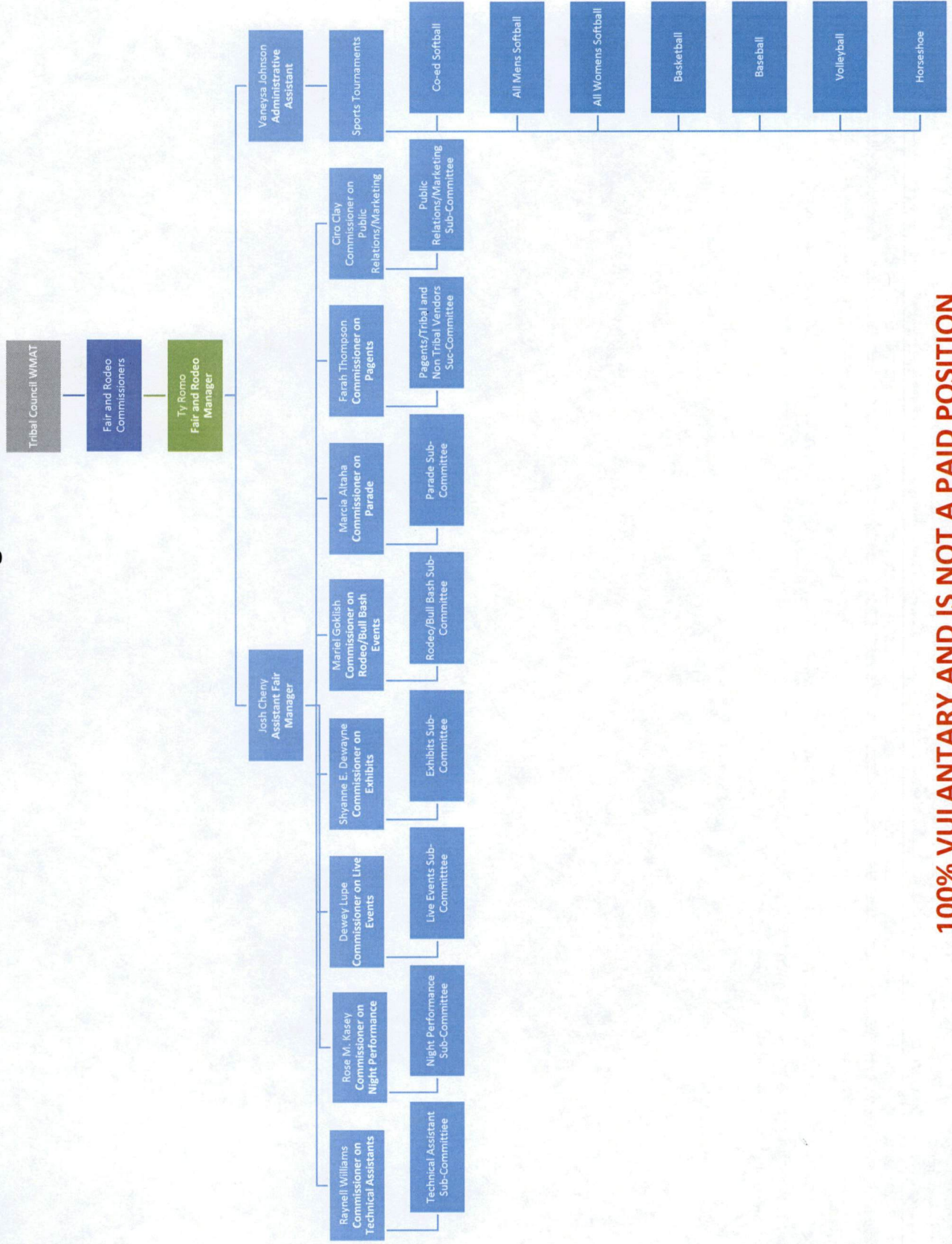
