



WHITE MOUNTAIN APACHE TRIBE

(Approval of Road Names for Hondah Resort and Casino's RV-Park)

WHEREAS, the population and housing on the Fort Apache Indian Reservation ("FAIR") has increased substantially since Resolution No. 05-2012-34 *Approval of White Mountain Apache Tribe's Road Inventory Update* was passed; and

WHEREAS, the need for a complete street address system throughout the FAIR is vital for providing emergency services as well as non-emergency services such as: utilities, telephones, UPS and mail delivery, etc. for the residents and visitors of the FAIR. The AZ Enhance 911 system requires a complete street address system for the Fort Apache Indian Reservation; and

WHEREAS, Hondah Casino has developed unofficial street names within the RV-Park which is recommended to be adopted into the Tribal 911 Emergency Addressing System; and

WHEREAS, the Tribal Council concurs with the Transportation Director to establish a street address system for the Hondah Resort and Casino's RV-Park.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Hondah Casino RV-Park road names for the completion of the 911 addressing system for the Hondah RV-Park.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JUNE 15, 2016** duly adopted by a vote of **TEN** for, **ZERO** against, and **ZERO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
