



# WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

## ( Authorizing Emergency Call-ins for Police Department Personnel and Allowing Community Service Personnel to Work 72 Hours )

---

**WHEREAS,** Resolution 05-2015-78 reduced business hours and limited employees to work 64 hour pay periods; and

**WHEREAS,** due to emergency situations, certain employees with the White Mountain Apache Police Department have been called in to work beyond their 64 hours; and

**WHEREAS,** due to funeral and burial services provided to families on weekends, certain Community Service employees have worked beyond their 64 hours; and

**WHEREAS,** after careful consideration, the Tribal Council finds it in the best interest of the Tribe to allow emergency call-ins for Police Department personnel and to increase the work hours from 64 to 72 hours per pay period for Royce Ethelbah, Albert Joe Standing and Dallas Nosie.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Chief of Police to allow emergency call-ins for Police Department personnel with an understanding that each call-in is justifiable and that the policy is not abused.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache tribe that it hereby authorizes an increase in work hours from 64 hours to 72 hours per pay period for Royce Ethelbah, Albert Joe Standing and Dallas Nosie of the Community Service Department.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.







**Resolution No. 06-2016-135**
