



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Land Assignment Approval for White Mountain Apache Housing Authority and Rainbow Treatment Center)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

WHEREAS, the Land Board members approved 2 business applications and 1 relinquishment for the White Mountain Apache Housing Authority and the Rainbow Treatment Center on December 14, 2016 for assignments located in Cibecue for new home construction and a Substance Abuse Program; and

WHEREAS, the White Mountain Apache Housing Authority is in the process of submitting an application for Tax Credit Dollars in hopes of constructing 20 new homes and rehabilitating 25 (or more) units in Cibecue, and is also planning to include a community building; and

WHEREAS, the proposed business site will need immediate access by Housing Authority and its Service and Support Team in order to secure funding and address development planning, and therefore, the Housing Authority is seeking approval from the Tribal Council; and

WHEREAS, the Rainbow Treatment Center was approved for a business assignment in Cibecue June 2012 for development of a Substance Abuse Program. However, it is advised that the land has not been used or developed by the Rainbow Treatment Center. Therefore, Rainbow Treatment Center would like to relinquish the land to WMAHA and requests for land located South of the Cibecue Commercial Center; and

WHEREAS, the Tribal Council has reviewed the applications presented and concurs with the recommendation of the Land Office and finds it in the best interest of the Tribe to approve two business applications for White Mountain Apache Housing Authority and Rainbow Treatment Center and one relinquishment for Rainbow Treatment Center.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves two business applications for the White Mountain Apache Housing Authority and Rainbow Treatment Center and one relinquishment for Rainbow Treatment Center for land in Cibecue for the construction of new homes and a Substance Abuse Program.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


