



# **WHITE MOUNTAIN APACHE TRIBE**

A Sovereign Tribal Nation

## **( Approval to Host 2017 Native Vision Camp )**

---

**WHEREAS**, the Tribal Council of the White Mountain Apache Tribe in conjunction with Johns Hopkins University has worked collaboratively for more than 35 years to raise the level of health of all residents of the Reservation; and

**WHEREAS**, Johns Hopkins, in partnership with the White Mountain Apache Tribe has agreed to assist in efforts to find ways to raise the self-sufficiency of Native communities to the highest possible level and to promote and celebrate all that is healthy and positive in the lives of our Native Youth; and

**WHEREAS**, Johns Hopkins Center for American Indian Health is requesting to hold the Native Vision Sports and Lifeskills Camp, scheduled for June 15-17, 2017 to celebrate the 21<sup>st</sup> anniversary year of the Camp and the 7<sup>th</sup> year the White Mountain Apache Tribe will serve as host; and

**WHEREAS**, the Tribal Council further finds that the Tribe, as host for the 2017 Native Vision Camp, should provide, as in years past, the following: *Port-a-johns, security provided by Tribal Police Dept for duration of camp, EMT's services for duration of camp, and Welcome Address/Farewell Ceremony and All-Star Basketball Game Presentations* during the 2017 Native Vision Camp to be hosted on the White Mountain Apache Tribe June 15-17, 2017;

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. The Native Vision Sports and Lifeskills Camp, scheduled for June 15-17, 2017, is hereby approved.
2. In-kind support is hereby authorized for the above listed items and services.
3. Public Works is hereby requested to provide in-kind support for Port-a-johns.
4. Tribal Police Department is hereby requested to designate officers and provide in-kind security services during Camp.
5. EMS Department is hereby requested to designate personnel and provide in-kind Emergency services during Camp.
6. Authorizes that the Johns Hopkins Center for American Indian Health will serve as the coordinating group for the Native Vision Sports and Lifeskills Camp, June 15-17, 2017 in Whiteriver, Arizona.



**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**Resolution No. 02-2017-26**

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **FEBRUARY 8, 2017** duly adopted by a vote of **EIGHT** for, **ZERO** against, and **ONE** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
