

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approval to Grant Tribal Relinquishment Request of Isaiah Talkalai)

WHEREAS, Tribal Member, Isaiah Talkalai has requested that his tribal membership with the White

Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with

San Carlos Apache Tribe; and

WHEREAS, the Tribal Enrollment Committee reviewed and approved the relinquishment requests at a

duly called meeting; and

WHEREAS, the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee

that the relinquishment from tribal membership be approved for Isaiah Talkalai.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Isaiah Talkalai, along with any and all privileges accorded to members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove Isaiah Talkalai from the membership rolls of the White Mountain Apache Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or, any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>APRIL 05, 2017</u> duly adopted by a vote of <u>NINE</u> for and <u>ZERO</u> against with <u>TWO</u> abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 284).

I, Tsaigh Talkala, an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, do hereby of my own free will, as an adult over the age of 18 years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to remove me from the Tribal Census Rolls of the White Mountain Apache Tribe to enable me to enroll with the San Carlos	
Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be TOTAL AND IRREVOCABLE. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
