

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approval for Filming Permit for Walking the Healing Path and the Department of Tribal Social Services)

WHEREAS, the Tribal Social Services Department will be coordinating with John Tsosie and the Walking the Healing Path for a domestic violence awareness event in June; and

WHEREAS, Walking the Healing Path is an annual awareness walk that occurs on various Indian reservations in the Southwest. This year the walk will start from Window Rock and will end at the Chief Alchesay Activity Center; and

WHEREAS, in February 2014, Mr. Tsosie and numerous representatives of the Walking the Healing Path coordinated with the White Mountain Apache Tribe and hosted the Project Peace Train Youth Conference. This successful event resulted in designating the White Mountain Apache Tribe as a future ending location for the 2017 walk; and

WHEREAS, Mr. Tsosie has coordinated with the Tribe's Social Services Department in hosting a conference at the end of the walk; and

WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to approve a filming permit for John Tsosie and the Tribal Social Services Department.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the issuance of a filming permit to John Tsose for filming on the Fort Apache Indian Reservation and as detailed in the proposed filming permit.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on MAY 3, 2017 duly adopted by a vote of EIGHT for, ZERO against, and TWO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
