



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Native Vision Annual Camp Filming Permit)

WHEREAS, the White Mountain Apache Tribe and Johns Hopkins University have worked collaborated for 37 years to support tribal members with various programs developed and implemented; and

WHEREAS, the Tribal Council approved for the White Mountain Apache Tribe to host the 21st annual Native Vision Sports and Life Skills Camp schedule for June 15 – 17, 2017; and

WHEREAS, Lacrosse is one of the six sports offered during Native Vision Camp which Mr. Robert Carpenter is a former collegiate athlete and founded InsideLacrosse.com, an organization that highlights the game of Lacrosse and the Native American players; and

WHEREAS, Mr. Carpenter is working on a feature-length documentary about the sport of lacrosse, starting with its Native American roots and honoring the peoples who created the game and is requesting permission to film this particular sport during the Native Vision Camp on June 16, 2017; and

WHEREAS, this documentary is being supported by Johns Hopkins/Native Vision and the Tewaaraton Foundation to further promote and expand Johns Hopkins' work with White Mountain Apache and other Native youth; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe finds it in the best interest of the Tribe to approve the filming permit for the Native Vision Camp.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the filming of Native Vision on June 16, 2017 which will highlight the game of Lacrosse and promote the efforts of Johns Hopkins/Native Vision, the White Mountain Apache and other Native youth.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby restricts any for profit use by Mr. Robert Carpenter or Johns Hopkins University.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

Resolution No. 06-2017-151

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


