# WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

**( Allocating \$20,000.00 for 2018 Inauguration Budget )**

WHEREAS, pursuant to Resolution No. 04-2018-75 and the Election Code, members of the Tribal Council recently certified the 2018 General Election for newly elected officials; and

WHEREAS, due to the economy and financial challenges during uncertain times, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe that a consolidated budget of no more than \$20,000.00 be authorized to cover all expenses related to the 2018 inauguration ceremony and festivities, and that Hon-Dah Casino shall assume all reasonable costs associated with the inaugural ball.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Treasurer to consolidate the inauguration budget, allocating a total not to exceed \$20,000.00 for the 2018 inauguration ceremony and festivities in celebration of our newly elected officials.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Hon-dah Casino to assume and/or waive the costs associated with the inaugural ball.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on APRIL 11, 2018 duly adopted by a vote of SIX for, ZERO against, and FOUR abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
