

## WHITE MOUNTAIN APACHE TRIBE

## A Sovereign Tribal Nation

(Authorizing Inter Agency Community Committee to Submit Grant Application to Community Services Block Grant for FY 2018 and FY 2019-2020)

- **WHEREAS**, the Inter Agency Community Committee ("IACC") has been a department within the Division of Health Programs for 18 years; and
- WHEREAS, funding assistance is needed to continue services for members of the White Mountain Apache Tribe that relate to drop-out prevention, domestic violence, suicide and sex offender registration and notification; and
- WHEREAS, the IACC, through Division of Health Programs, submitted a proposal to the U.S. Department of Health and Human Services Administration for the community services block grant available through the Children and Families Office of Community Services for FY2018, which if approved will provide funding for one year; and
- WHEREAS, an allowable assurance is define as, "A. Programmatic Assurances (1)(a)(i) to remove obstacles and solve problems that block the achievement of self-sufficiency," for families and low income individuals; and
- WHEREAS, the Division of Health Programs seeks approval to apply for the FY 2018, FY 2019-2020 Community Services Block Grant every year; and
- **WHEREAS**, the Tribal Council finds it in the best interest of the Tribe to approve the submission of a grant application as specified herein.
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Division of Health Programs to submit a grant application for FY 2018 Community Services Block Grant to the Offices of Community Services, U.S. Department of Health and Human Services and approves and authorizes all assurances and understanding contained within said application for FY 2018 and FY 2019-2020.
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

## Resolution No. 06-2018-131

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>JUNE 13, 2018</u> duly adopted by a vote of <u>TEN</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
