

## WHITE MOUNTAIN APACHE TRIBE

## A Sovereign Tribal Nation

(Approval of Individual & Community Water & Sewer Facilities)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, the Tribal Engineer's Office and the Attorney General's Office have reviewed this Indian Health Service Construction boiler plates; and

WHEREAS, the Tribal Council concurs with the Tribal Engineer's Office and acknowledges the language as written for all Indian Health Service funded construction projects taking place on the Fort Apache Indian Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Chairwoman, or in her absence, the Vice-Chairman, to execute contract renewals, after the form and content thereof is negotiated and agreed to by the Office of the Attorney General and the Tribal Engineer, and to execute any future contracts that are substantially in the same form and content as presented.

**BE IT FURTHRE RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves WMAT/IHS Individual & Community Water & Sewer facilities Project Manual.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **NOVEMBER 28, 2018** duly adopted by a vote of **TEN** for, **ZERO** against, and **ONE** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
