



# WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

## (Amending Resolution 04-2019-65 and Approving Land Restoration Fiscal Year 2019-2022 Budget for Land Restoration Administration, Proposed Projects, Scholarship, & Internship)

---

**WHEREAS,** The Constitution of the White Mountain Apache Tribe (“Tribe”) of the Fort Apache Indian Reservation (“Constitution”) provides, at Article IV, Section 1(f) that the Tribal Council (“Council”) shall exercise the power “To protect and preserve the wildlife, plant life, forests, natural resources and water rights of the Tribe...”; and

**WHEREAS,** By Tribal Council Resolution No. 04-2019-65, the Council approved the Land Restoration FY2019-2020 budget for administration, proposed projects, scholarships and interns; and

**WHEREAS,** At the request of the Land Restoration Board, the Council finds it in the best interest of the Tribe to extend the fiscal year for three years from 2019-2022 for Budget for Proposed Projects, Scholarships, and Internships or the Land Restoration Program.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the 2019-2022 fiscal year budget for Proposed Projects, Scholarships, and Internships for the Land Restoration Program.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on MAY 20, 2019 duly adopted by a vote of TEN for, ZERO against, and ZERO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
