



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approving a Location Release, Materials Release and Appearances Release between The People's Farm and Brentwood Communications International, Inc. for "The Fixers" Television Production)

- WHEREAS,** The Constitution of the White Mountain Apache Tribe of the Fort Apache Indian Reservation provides, at Article IV, Section 1(g) that the Council shall exercise the power "To cultivate Indian arts, crafts, and cultures"; and
- WHEREAS,** On September 12, 2018, the Tribal Council "Council", via Resolution No. 09-2018-197 delegated the authority to issue film and still photography permits to the Tribe's Office of the Attorney General; and
- WHEREAS,** On January 11, 2019, the Office of the Attorney General issued Brentwood Communications International, Inc. a filming permit for February 2—8, 2019 to film an episode of the "The Fixers" Television Production on the Fort Apache Indian Reservation; and
- WHEREAS,** The production activity included the repurposing of an abandoned saddlery to become a produce market in order to bring fresh produce and commerce to the community and reinvigorate traditional agricultural practices; and
- WHEREAS,** Brentwood Communications International, Inc. is requesting Ndee Bikiyaa (The People's Farm) execute a Location Release, Materials Release, and Appearance Releases for the persons who appear in the production (collectively the "Releases") (attached and incorporated herein by reference); and
- WHEREAS,** The Office of the Attorney General negotiated the terms of the Releases with the Producers and their attorney, and finds them suitable and protective of the Tribe's interests; and
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe finds that approval of the releases will help the Tribe promote the mission of the People's Farm and assist with the education of the Tribe's members about sustainable and healthy living through traditional agriculture, and is in the best interests of the Tribe and its members.
- BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Location Release, Materials Release, and the form of the Appearances Release, between the People's Farm and Brentwood Communications, Inc. for production of "The Fixers" Television Production.

Resolution No. 06-2019-114

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JUNE 12, 2019** duly adopted by a vote of **ELEVEN** for, **ZERO** against, and **ZERO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
