

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approval to Grant Tribal Membership for 30 Applicants)

WHEREAS, pursuant to the Enrollment Code and the Tribal Constitution, the Tribal Enrollment Committee is designated to ensure that all requirements are met by each applicant who wishes to become an enrolled member of the White Mountain Apache Tribe; and

WHEREAS, on behalf of the Tribal Enrollment Committee, the Enrollment Officer presented a list of thirty (30) applicants who have applied for and met all requirements for membership with the White Mountain Apache Tribe; and

WHEREAS, the Tribal Council concurs with the Tribal Enrollment Committee that the thirty (30) applicants be granted Tribal membership.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the thirty (30) applicants enrollment with the White Mountain Apache Tribe based on the recommendations of the Tribal Enrollment Committee and pursuant to the attached list, subject to rescission pursuant to the Tribal Enrollment Code Sections 1-202(a) and 1-704.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>AUGUST 22, 2019</u> duly adopted by a vote of <u>ELEVEN</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
