



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Authorizing Grant Application for the Coronavirus Emergency Supplemental Funding Program Solicitation FY2020 Formula Grant Solicitation)

WHEREAS, The Constitution of the White Mountain Apache Tribe (“Tribe”) of the Fort Apache Indian Reservation (“Constitution”) provides, at Article IV, Section 1(j) that the Tribal Council (“Council”) shall exercise the power “To accept grants and donations from any person, State or the United States”; and

WHEREAS, A funding opportunity for White Mountain Apache Police Department (“WMAPD”) for fiscal year 2020 exists through the Department of Justice (“DOJ”), Office of Justice Programs, Bureau of Justice Assistance Grant (“BJA”) Coronavirus Emergency Supplemental Funding (“CESF”) Program; and

WHEREAS, WMAPD performs law enforcement functions and is eligible to apply under the CESF, and

WHEREAS, One-time funding in the amount of \$218,971.00 is potentially available to the Tribe; and

WHEREAS, If awarded, the Police Department will utilize such funds for the purposes of local prevention, preparation and response to the COVID-19 pandemic; and

WHEREAS, WMAPD, this day, requests authorization to apply for the CESF program grant; and

WHEREAS, The Council has considered WMAPD’s request and finds that authorizing application for the CESF grant will help WMAPD fund essential public services and is in the best interests of the Tribe and its members.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the White Mountain Apache Police Department to prepare and submit a grant application to the Department of Justice, Bureau of Justice Assistance for the Coronavirus Emergency Supplemental Funding Program Solicitation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that, if awarded, the Tribal Treasurer is authorized to accept such monies on the Tribe’s behalf, and establish accounts for receipts and expenditure thereunder.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal

Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


