



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Appropriating \$9,927.00 for the Tribe's Vital Records Department to Purchase A New Printer for Creating Tribal Identification Cards)

WHEREAS, The Constitution of the White Mountain Apache Tribe ("Tribe") of the Fort Apache Indian Reservation provides, at Article IV, Section 1(k) that the Tribal Council ("Council") shall exercise the power, "To appropriate Tribal funds for tribal purposes..."; and

WHEREAS, The Tribe's Vital Records Office, in addition to its other duties, prepares and creates Tribal identification cards for the members of the Tribe; and

WHEREAS, Creating these ID cards requires a working specialty printer; and

WHEREAS, Vital Records, this day, advised Council of the insufficiency of their current old printer and requested funds to purchase a new one; and

WHEREAS, The Tribe's Information Technology Department has identified a suitable replacement printer, which costs \$9,927.00; and

WHEREAS, The Council finds replacement of the old printer is necessary at this time, and will enable the Vital Records Office to continue to provide valuable services for the Tribe and its members.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that \$9,927.00 is hereby allocated for the purchase of a replacement printer capable of creating Tribal Identification cards, and that the Tribe's IT Department shall facilitate such purchase and delivery.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **AUGUST 5, 2020** duly adopted by a vote of **ELEVEN** for, **ZERO** against, and **ZERO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
