

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approving Land Board's Recommendations Regarding Land Applications for 9 Applicants)

- WHEREAS, The Constitution of the White Mountain Apache Tribe ("Tribe") of the Fort Apache Indian Reservation ("Constitution") provides, at Article IV, Section 1(m) that the Tribal Council ("Council") shall exercise the power "To provide by ordinance for the assignment, use, or transfer of tribal lands within the reservation"; and
- WHEREAS, Section 2 of the Tribe's Land Code provides the Council with the authority to approve or disapprove of recommendations made by the Land Board for the assignment of Tribal lands; and
- WHEREAS, The Land Board, this day, comes before the Council and request approval of eleven (11) land applications from March and April of 2021, consisting of 9 homesites, 1 farmland and 1 relinquishment which applications are attached hereto and incorporated herein by reference; and
- WHEREAS, The Council has reviewed the applications presented, concurs with the recommendations of the Land Board, as to those 9 applicants who have acreage listed on their applications, and finds that approving those 9 applications is in the best interests of the Tribe and its members.

NOW THERFORE, BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the attached 9 applications for land assignments that contain listings of acreage (comprising eight homesite applications and one farmland application) are hereby approved.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>MAY 11, 2021</u> duly adopted by a vote of <u>TEN</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
