

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Appointing Land Restoration Board Members)

WHEREAS, Section 3.1(A) of the White Mountain Apache Land Restoration Code provides that a seven-member Land Restoration Board with a representative from each district, one young Tribal member, one elder Tribal member and one Tribal member with a degree be appointed by the Tribal Council; and

WHEREAS, The Land Restoration Program Manager advises that the District II Representative, the District IV Representative and the Young Adult Representative all resigned from the Board, creating three vacancies; and

WHEREAS, The Tribal Council recommends that the following individuals be appointed to fill the vacancies on the Land Restoration Board:

- District I Judy Dehose
- District II Marian Patterson
- District III Floyd Walker
- District IV Kristy (Antonio) Gregg
- Young Adult Representative Dustin Rector
- Elder Representative Raymus Albert
- Land Restoration Coordinator Beverly Nastivar
- Ecological Management Representative Ida Rose Cosay

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints the following individuals to serve on the Land Restoration Board for a term of one, two or three years to be determined at an official Land Restoration Board meeting; pursuant to the Land Restoration Code:

District I - Judy Dehose Young Adult Representative - Dustin Rector

District II - Marian Patterson Elder Representative - Raymus Albert

District III - Floyd Walker Land Restoration Coordinator - Beverly Nastivar

District IV - Kristy (Antonio) Gregg Ecological Management Representative - Ida Rose Cosay

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
