

# WHITE MOUNTAIN APACHE TRIBE

### A Sovereign Tribal Nation

(Approving the 2022 Ceremonial Sunrise Dance Schedule)

WHEREAS, The Constitution of the White Mountain Apache Tribe ("Tribe") of the Fort Apache Indian Reservation ("Constitution") provides, at Article IV, Section 1(a) that the Tribal Council ("Council") shall exercise the power "[t]o represent the tribe and act in all matters that concern the welfare of the Tribe, and to make decision not inconsistent with or contrary to this constitution"; and

WHEREAS, the Tribal Council Secretary maintains a schedule of Sunrise Dance ceremonies on a yearly basis to make sure that no inconsistencies occur between the sponsoring families; and

**WHEREAS**, a detailed schedule that reflects the information provided by the sponsoring families has been presented to the Tribal Council; and

WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to honor and adopt the 2022 Sunrise Dance Schedule, attached and incorporated by reference, to facilitate the Sunrise Dance process for the benefit of all involved participants, subject to amendments throughout the year.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby declares attached Sunrise Dance schedule as the official Tribal Council sanctioned 2022 Ceremonial Sunrise Dance schedule of the White Mountain Apache Tribe, subject to changes and amendments throughout the year.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>MARCH 02, 2022</u> duly adopted by a vote of <u>ELEVEN</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and
