

## WHITE MOUNTAIN APACHE TRIBE

## A Sovereign Tribal Nation

(Authorizing Burial of Non-Tribal Member Susan Whiteford on the Fort Apache Indian Reservation)

- WHEREAS, The Constitution of the White Mountain Apache Tribe ("Tribe") of the Fort Apache Indian Reservation provides, at Article IV, Section 1(a) that the Tribal Council ("Council") shall exercise the power, "To represent the Tribe and act in all matters that concern the welfare of the Tribe..."; and
- WHEREAS, The Tribal Council has been advised that Susan Whiteford, a non-member of the Tribe who resided on the Fort Apache Indian Reservation for numerous years has passed away, and that her family desires for her urn to be buried on the Reservation at the Shadow Mountain Cemetery; and
- WHEREAS, The Tribal Council finds that the request provided herein is consistent with the culture and tradition of White Mountain Apache Tribe, who extends their sympathy to the Whiteford family and the Cibecue Community.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants permission to Ms. Whiteford's family to arrange the burial of Susan Whiteford's urn at Shadow Mountain Cemetery in Cibecue, Arizona on the Fort Apache Indian Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>APRIL 11, 2022</u> duly adopted by a vote of <u>ELEVEN</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
