WHEREAS, pursuant to Article XI, Section 3, of the Constitution of the White Mountain Apache Tribe, the Secretary of the Tribal Council is responsible for keeping and maintaining minutes of all Council meetings; and

WHEREAS, pursuant to Article XIII, Section 5 of the Constitution of the White Mountain Apache Tribe, the order of business requires a reading of the minutes; and

WHEREAS, the Tribal Council Secretary requested approval of the attached meeting minutes prepared from the Tribal Council meetings held on May 23, 2022, and

WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to approve the meeting minutes from the Tribal Council meetings held on May 23, 2022, as prepared and presented by the Tribal Council Secretary.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the briefs with supporting meeting minutes from the Tribal Council meetings held on May 23, 2022, as prepared and presented by the Tribal Council Secretary.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>JULY 6, 2022</u> duly adopted by a vote of <u>NINE</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).

I. CALL TO ORDER

- A. The meeting was called to order at 9:03 A.M. by Chairman Velasquez
- B. Prayer was offered by Jerold Altaha

Chairman Velasquez requested that this be discussed next month and that the Tribal Council review the Organizational Chart and the Tribal Administrator Position.

III. NEW BUSNIESS

A. Introduction – KENEW, LLC

Councilman Gary Alchesay presented Project Manager from KENEW, LLC Construction Management. Bob Terry and Chad Hafstrom introduced themselves. Mr. Terry stated that he sits on the Executive Board for Construction in Indian Country and teach classes. Also on the Executive Board for American Indian Chamber of Commerce, he said they pride themselves because they give back to the community with their work. Mr. Terry said that Indian Country is attached with Arizona State University and has worked with them for the last couple of years. They have worked with San Carlos Housing Projects, Head Start facilities and the Game & Fish Department. Also with Navajo, Chinle, and Tuba City.

Chad Hafstrom moved from Minnesota to Ganado, Arizona in 1993. Mr. Hafstrom stated that just in Navajo alone he has worked with 150 million dollars. Also stated that he assisted in the Emergency Operations Center Building, Housing remodeling and together the two have 30 plus years in experience working with tribes in the United States. They also worked on the McNary School.

Milford Cosen informed the Tribal Council that a 12 million dollar grant for a new Daycare has just been sitting there; going into the 3rd year with nothing being done about it. He stated that the Federal Grant gives up to 3 years to do something with the money. Now that KENEW are here they are going to be working on it. Mr. Cosen said that the Federal Government can take the money back, if nothing is being done about it. Milford said another project is the Head Start and that it's layout is similar to the Daycare.

Mr. Cosen said that Head Start does have conceptual drawings and cost estimates, there is a grant that they want to get and apply for next week. He stated that the tribe could save some money if KENEW help with the value engineering on the estimates before they apply for the grant. Chairman Velasquez requested that Milford take the information on the 12 million dollar grant to Attorney General's Office for review. Mr. Cosen requested that they get on the agenda for the next council meeting.

Councilwoman Westover said the DOC building is over looked and is so unsafe in her opinion; she suggested that they bring this concern up to the Bureau of Indian Affairs (BIA). Councilman Altaha stated that we have to continue to push BIA because resolutions were passed and still nothing has been done. Councilman Beach said the DOC building is shifting and all these things should have been considered when it was being constructed. He suggested that a new building be built somewhere else, this can be brought up again and there is no can't, this can be done. Councilwoman Craig said a lawsuit is needed for this issue and we can't sit back.

- Councilwoman Mariddie Craig motioned to direct the Attorney General's Office for options to take legal action against the Bureau of Indian Affairs, Fort Apache Agency. Seconded by Councilman Jerold Altaha with a comment to add that other tribe's file litigation to up hold the sovereign laws of the Tribe.
