

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approving Ownership Transfer for Tribal Mobile Trailer to Tribal Member)

- **WHEREAS**, Pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- **WHEREAS**, the Tribal Council sees that there is a need to help tribal member Ms. Verna Kahn as her house burnt down and she currently does not have a home and is taking care of her family members; and
- WHEREAS, Ms. Kahn has been without a home for years and has been unable to get housing assistance from the White Mountain Apache Housing Authority and other agencies; and
- WHEREAS, the Tribe owns a vacant Mobile Home that sits next to the current Tribal Fair and Rodeo Office ("Mobile Home") that has not been assigned to any department; and
- WHEREAS, the Tribal Council finds that it is in the best interest of the Tribe to give the ownership of the Mobile Home to Verna Kahn as is, provided she sign a release of liability that releases the Tribe from any claims associated with the Mobile Home, and that if tribal funds are allowable and available through ARPA or another source, the Tribe will utilize said funds to transport the Mobile Home to her address in Canyon Day.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the ownership transfer of the Mobile Home to Ms. Verna Kahn and it will be transferred to her as is, provided she sign a release of liability that releases the Tribe from any claims associated with the Mobile Home, and the Tribe shall utilize ARPA funds or other tribal funds, if allowable and available, to transport the Mobile Home to her address in Canyon Day.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on AUGUST 3, 2022 duly adopted by a vote of EIGHT for, ZERO against, and TWO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it underthe enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on November 10, 2021, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
