



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Authorizing Cedar Creek Assembly of God to Conduct its Annual Camp Meeting from June 1 to June 10, 2023)

- WHEREAS,** The Constitution of the White Mountain Apache Tribe of the Fort Apache Indian Reservation (“Constitution”) provides, at Article IV, Section 1(a) that the Tribal Council (“Council”) shall exercise the power “To represent the tribe and act in all matters that concern the welfare of the Tribe”; and
- WHEREAS,** The Tribe has always had a thriving and active faith community, which benefits the Tribe’s members individually and the community as a whole; and
- WHEREAS,** The Cedar Creek Assembly of God has proposed that it conduct its annual camp meeting from June 1 to June 10, 2023, and this day seeks authorization from the Council to do so; and
- WHEREAS,** Council finds that authorizing the propose camp meeting will help strengthen the faith in these tumultuous times, and is in the best interests of the Tribe and its members.
- BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that Cedar Creek Assembly of God is hereby authorized to conduct its annual camp meeting from June 1 to June 10, 2023.
- BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.
- BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.
- BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

Resolution No. 02-2023-51

The foregoing resolution was on **FEBRUARY 28, 2023** duly adopted by a vote of **NINE** for, **ZERO** against, and **ZERO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on November 10, 2021, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
